# Letter from Incoming Chairperson: Jennifer Emett

## INCOMING MESSAGE

I'd like to take this opportunity to welcome the members of our Board of Directors for the 2024-25 fiscal year. I am grateful for the opportunity to serve this community as your chair and look forward to a very challenging year. I trust in the passion of each board member and their desire to do the right thing for Pine Mountain Club and its residents.

The board members attended three days of orientation and training and have each volunteered to perform as liaison to standing committees along with Fire Safe Council. There are several committees that need more members. Please consider joining a committee; it's never too late to be involved. In fact, some committees have not had their first meeting for this year.

The project manager for the clubhouse renovations met with the board to answer any questions they had regarding the project. While there were eight general contractors solicited to bid, four came forward with their proposals. The board has requested to meet with each contractor, in person if possible.

To be clear, the project has not been approved to move past the construction bidding phase, therefore, viable construction and funding options have not been discussed.

One of the urgent goals for this board is to approve a reserve specialist to perform a full detailed physical reserve study. We need to understand the current state of the PMC POA assets, their remaining useful life and estimated cost of replacement. This study will include all components of the clubhouse. This analysis will be vital input to all renovation decisions.

I met with the Equestrian Center (EQ) Manager. She provided a very detailed analysis of her tenure as manager over the past eight years. A key takeaway was her discovery that other boarding ranches in our area provide employee housing, allowing them to pay minimum wages with little overhead while we strive to pay our staff a living wage. We will continue to discuss options for additional income streams and we're hopeful to bring the EQ closer to break even.

I'm frequently asked, "What is the board doing about the bears?" This is a huge problem that has resulted from several sources but the most concerning are generational habituation and higher requirements to issue depredation permits. The PMC POA Patrol is taking proactive measures to haze bears off of residential home sites, working with California Dept Fish and Wildlife (CDFW) and maintaining bear attempts and break-in location log, uploaded up to the Facebook page.

# Update from General Manager: Todd Greisen

## MANAGER UPDATE

One of our hot topics, continues to be bear break ins. If you visit our website, you will find a map with updated incidents reported to us. If you are a victim, or even see a bear, or bears, on your property please report details to Patrol. For immediate response, please call them at 661-556-1685. Simple observations, such as on your doorbell camera, can be reported to [patrol@pmcpoa.com](mailto:patrol@pmcpoa.com). Incidents should also be reported to California Department of Fish and Wildlife

In spite of all the media attention we're getting, efforts from California Department of Fish and Wildlife have been inadequate to mitigate the problems residents face. In case you haven't seen it already, please complete the online petition to state officials requesting they step up their efforts to help solve the problem coming from the national forest surrounding Pine Mountain Club. Our state government needs to hear from its voters. Because the problem has become generational, as in mama bears teaching their cubs, temporary solutions are clearly ineffective.

We are also taking action in PMC common areas for which we are responsible. A key area within our responsibility is the transfer site, where food waste is among the resident-disposed trash. Although additional fencing has been suggested, it's proven that bears will not be deterred by it, any more than they are deterred by other means of property protection. Electrified deterrents are under consideration and we hope to have solutions in place soon.

Along with the bear season, we have also dealt with a lot of heat this summer. Please remember that the clubhouse is air conditioned, and is open 8 to 5 daily, with free WiFi available to keep you cool and connected. The pool has also been a very popular amenity this summer. Staff reports to me that they've had to turn away visitors because we've reached capacity for safe swimming. I'm thankful to past board of directors who had the foresight to replace the smaller pool a few years ago, which would have been at capacity even more with the increased population of PMC in recent years. In addition, recent evenings at the lounge and restaurant have been among our busiest in recorded history, where food and entertainment can be included with your effort to remain cool. The kitchen and staff have also been pushed to their limits to support the needs of the community.

Of note regarding capacity, it's now evident that our post office is also running beyond its limits. In addition to PMC's population growth in recent years, the growth of online purchasing and changes in delivery methods has stretched our ability to service our customers. We continue to be just as busy as the peak holiday season on a daily basis. Amazon Prime is the dominant product provider who's impacted delivery by sending most items

to your post office instead of to your door, pushing our small-town post office to its limits almost daily. Package pick up from Frazier Park post office often requires several trips per day by staff, who then must temporarily store and sort packages, followed by placing notices in your mailbox.



It is at that point that they have officially been delivered, contrary to what your phone app may tell you. It's an overwhelming task, and your patience is appreciated as we do our best to continue service at this amenity.

We continue efforts to maximize the space available in the post office. As you peak through the front window, you can get a glimpse of the limitations we face. Floor space is a premium, where boxes can be temporarily stacked until resident pick up. Like many of you, staff is dealing with the hot weather. Our portable floor AC unit has recently been replaced with central air, keeping staff cool while adding just a bit more space where packages can be stored. More to come. Other infrastructure moves are underway to add more space for the package volume we process daily.

We continue to maximize space in the clubhouse, too. Facilities maintenance has moved their office out to the old pool pump house, where modifications have been made to accommodate staff and equipment storage. This has opened up more dining space in the Condor room, to allow for the greater demand of the lounge and restaurant.

Maintenance staff is also working on clearing an area we refer to as the 'contractor yard', putting us in a position to open additional RV storage facilities, increasing the capacity of that amenity and source of revenue. Other projects in the works by maintenance staff include annual slurry of some of our roads. For those of you who may be new to PMC, there is an ongoing schedule of road slurry each year, followed by restriping. This year, we're also adding roadway speed and 'stop ahead' warnings, to encourage safer driving. If your street was not impacted by this year's improvements, please know that you're on the schedule for the future.

Other, less critical, improvements to the golf course and Lampkin Park amenities are also in the works. Tee boxes are being leveled and we're adding foliage barriers to the north side of the lake where many golf balls are lost due to its proximity to the driving range. We're adding shading to the park and ball field grandstands to help with the summer heat. Lighting and fencing improvements to the tennis and pickleball courts continue as staff time allows.

Fern's Lake has been restocked this summer, and we've made some other minor improvements to that amenity. The Equestrian Center continues to expand its services to improve revenue and support the boarding community.

By purchasing the Askin (a.k.a. post office) building, we've become new members of the commercial properties' owners association. This has opened the door to work closer with them on events and other ways to invigorate our small-town economy and maintain property values. As always, I continue to look for ways to keep amenity costs low, while improving the opportunity for revenue increases to minimize subsidies. Both approaches are essential to keeping annual assessments as low as possible, during tough economic times that we all face. Thank you all for your support, as I do all I can with the support of the board of directors, to make Pine Mountain Club the best mountain community to live and visit in southern California.

# Biological Pest Control on Invasive Knapweed

Biological pest control offers several benefits over chemical methods. It's more environmentally friendly, as it doesn't involve the use of toxic chemicals that can harm the ecosystem. It's also a sustainable approach, as it relies on natural predators and parasites to regulate pest populations. Additionally, biological pest control is often more targeted, affecting only the intended pest species and minimizing harm to beneficial organisms. This method also has the potential to be cost-effective in the long term, as it can lead to reduced reliance on expensive chemical treatments.

The utilization of *L. obtusus*, flower weevils, for biological control of spotted knapweed, *Centaurea stoebe*, in Los Padres National Forest involves introducing the beetle to the area. *L. obtusus* has been found to effectively control the population of spotted knapweed by feeding on the plant and inhibiting its growth and spread. The beetle's feeding activity reduces the vigor and reproductive capacity of the knapweed, contributing to its control without causing harm to other native plant species. This biological control method has been studied and implemented as an environmentally friendly approach to managing the invasive species in the forest ecosystem.

I had an opportunity to visit the spotted knapweed hot spots with PMC Resident Elisa Christensen. Christensen spoke to our weevil supplier in Montana (where knapweed is most invasive), and the suppliers had great news. The Montana weevil suppliers said that since spotted flower weevils were placed in certain hotspots last fall, and as far as we know, we have yet to release them in 2023, there is a good chance that weevils were released on the mountain in years past. This would have given them a few years to propagate and spread, which they do at a pretty good rate, given that flower weevils have wings. Christensen asked Joe Ladin, PMCPOA EC Officer, about this, and he said he remembered some discussion of weevils years back but couldn't recall the details.



On Monday, July 15th, Christensen and I checked several knapweed hotspots for flower weevils. If they are abundantly present, Christensen believes it unnecessary to order any. (FYI, the flower weevils are \$90 per release, and the root weevils are \$160.)

When we discovered the flower weevil present at several hotspots, we were very excited to see that the population did not die out after their release into the area over four years ago.

"The big key to all this is keeping the knapweed from being ground up in the green waste site and sent back out as mulch into our properties. I understand the cost of hauling the green waste off the mountain to Lebec would be considerable. Still, perhaps we could have a brainstorming session with the transfer site employees and EC on how we can greatly reduce the likelihood of the knapweed returning to the community," says Christensen.

What to look for in the coming weeks...

Starting this week and in the future, you will begin to see the pink flowers. Once this starts, and the flowers begin to turn brown and go to seed, it is critically important that we reduce the spread of the plant as aggressively as possible. If you see weevils on your knapweed, move them onto another plant or relocate them before throwing out the knapweed you collect throughout.

As a reminder, please pick up the yellow bags from the PMCPOA EC Office for collecting knapweed and dispose of them properly at the transfer site.

**Spotted Knapweed**

Spotted knapweed is a highly invasive, exotic plant native to Asia and Eastern Europe.

It is a short-lived perennial that reproduces by seed and produces a chemical that inhibits other plants from growing.

It is capable of producing dense monocultures that eliminate native and beneficial plants



### Grilling Safety During the Summer

#### **Safety Tips from the Emergency Preparedness Committee**

- Only propane and charcoal barbecue grills may be used outdoors, and should never be used indoors.
- The grill should be placed well away from the home, deck, railings and out from under eaves and overhanging branches.
- Keep children and pets at least three feet away from the grill area.
- Keep your grill clean by removing grease or fat buildup from the grills and in trays below the grill.
- Never leave your grill unattended.
- Always make sure your gas grill lid is open before lighting it.

#### **Charcoal Grills**

- There are several ways to get the charcoal ready to use. Charcoal chimney starters allow you to start the charcoal using newspaper as a fuel.



- If you use a starter fluid, use only charcoal starter fluid. Never add charcoal fluid or any other flammable liquids to the fire.
  - Keep charcoal fluid out of the reach of children and away from heat sources.
  - There are also electric charcoal starters, which do not use fire. Be sure to use an extension cord for outdoor use.
  - Place grill on a fire-proof base/material to protect decks from hot coals and sparks.
  - When you are finished grilling, let the coals completely cool before disposing of them in a metal container, and store the container away from your home.

## Grilling Safety During the Summer

### Propane Grills

- Check the gas tank hose for leaks before using it for the first time each year. Apply a light soap and water solution to the hose. A propane leak will release bubbles.
- If your grill has a gas leak that you detect by smell or the soapy bubble test and there is no flame, turn off the gas tank and grill. If the leak stops, get the grill serviced by a professional before using it again.
- If you smell gas while cooking, immediately get away from the grill and call the fire department. Do not move the grill.
- If the flame goes out, turn the grill and gas off and wait at least 15 minutes before re-lighting it.
- Remember, fire pits and open fires are prohibited in Pine Mountain Club. To homeowners who rent out their cabins and to those working at rental agencies, please ensure that your renters are informed of the [Pine Mountain Club Rules and Regulations](#).

## Wildlife

### Reminder: Do Not Feed Wildlife

Reminder: Rule 7.03. The feeding of or providing food in any manner to bears, mountain lions, bobcats, raccoons, deer, foxes and/or coyotes is strictly prohibited on any lot or other portion of the Pine Mountain Club development. "Feeding" includes giving, placing, exposing, depositing, distributing, scattering, or allowing food or any edible material to remain in the development that may attract wildlife. Food or any edible material left outside unattended is prohibited and is considered feeding the wildlife. This prohibition will be strictly enforced, and the California Department of Fish & Wildlife will be notified of any violations.

The deadline for taking in all bird seed, nuts, suet and hummingbird feeders was April 1, so they should be away for the season now as well.


